**Annotation:** This article presented the new reformatations on medical field primary medical-sanitation aid which is conducting by our current president in order to develop the system and improve people's life having to utilize state health care. The whole moderated configurations are based *on* the great purpose which our medical system can *be* competed with world health care standards, not only our citizens, even though it is bound to be the professional health centers where available to have the latest and most efficient therapies for foreign countries' people *who* need qualified care, *as* if in the past our land would be the Medical centers for among foreign countries.

**Key words:** primary medical-sanitation aid, the decree 6110, accoucheur-genecology centers, medical brigades, family physicians polyclinics, village physicians at long-distanced places, diagnosing beforehand, digitalization.

The current president got focused all attention *on* Health Care System which *he* mentioned highly critical medical problems on November 12, 2018. Sh. M. Mirziyoyev emphasized vital issues on Health Care System that are primary medical-sanitation service which including basically First Aid, also, financial-technical *bases* of region central hospitals, the degree of being provided with professed personnels, in family dispensaries, *as* well.

*As a* result of these situation the President justified the evidence that is people *who* need satisfactory medical service *have* to visit the Capital Health Centers or even go to foreign countries in order to have necessary wellness for life on valuable measure of payment at the sequential video selection meeting devoted to the development of Medical System, encircling of people of areas with the acceptable medical service, *as* well. Furthermore importantly supporting family dispensaries with financial- technical bases, the Head of our State counted *as* the main purpose of all reformatations is to improve people's life, *on* this way acceptable medical service played the big role to hold in its contents.

By these points of view, the president declared 50 decrees which are belonged to Health Care contained the forceful reformatations which engaged such measurable values of the State Budget, *as* if extra *bonus* salaries for experienced medics, increasing of their salaries, organizing new dispensaries, medical-scientific-practical points to develop the field. One of these *decrees* is about the course of immediate actions *on* complex development of Health Care System. The major aim of ratifying of this document is to amplify the State's Administration on Health Care System, modify the Primary Health Department *as* the scheme which to define early about illness and diagnose, cure immediately, prevent from serious effects, *as* well. Moreover, it is enlightened *as* widely exterimity to accelerate the Digitalization Progress *on* the System, expand the capacity of medical service, support the private section and contention, get the mid-working staff qualified totally and moderate Medical Education and Medical Science. Of course, it is efficiently productive way to define

disorderliness on one's body and diagnose in time in order not to become real health problem. It is completely significant to precise the reason of person's disturbance of health life and abruptly absolve symptoms with the basement of causes and control to follow the instruction of disinfection, withdrawing process. First Aid Construction must absolutely *be* capable to provide above goals, avoid heavy conditions of disease in time by diagnosing during light early period of unhealthy position and direct to necessary section which is able to function on resolving smoothly, otherwise not to have to spend more extra time and measurable cost of financial balance, and it is the most attentive side of circumstances to gain more painful difficulties and great inconvenient disturbance after overcaught the peak of sickness. Mostly, it *was* possible to solve health problems at family dispensaries *when* they would *be* just little unpleasant issue *on* health before they become *as* the top of illness, the most important purpose of these decrees, to modify the first aid constructions and family dispensaries *as* the primary basic fundamental position which is manageable to organize wise health solutions beforehand, instead of getting patients heavy conditions and send to the capital medical centers or foreign countries' institutes by high quantity of financial amount. As in people's life Health plays such a priceless! expensive role, that it is impeccable needful point to moderate according to Current World Health Demands. In that decree the Head of our State appointed accurately exact tasks *on* autonomous appropriate personnels. Following it is stated these personnels with *own tasks*.

The Matters of the Health minister: General governance on the belonging organizations of the Ministry, providing effective organizing of their function, personally responsible for administrating of conducting completely involved assignments and duties, operate these organizations and proclaim legal documents of supervising system affairs. *The next steps of* concerning responsibilities are *to* organize *the* function of *the* Urgent Medical Aid, and Republic Medicine (except from Republic Specialized Scientific-practical medical centers) establishments, assess the initiation of the supervisors of belonging department<sup>^</sup> of the Ministry and fire or appoint them; and also, carry out the authorities about holding tenders of the sale of medicine, equipments tools which is considered necessary for the health centers, withstand against corruption positions. *The* matters of the first deputy minister is intimately amenable for the increase in mid-proficiency staff's qualifications, the supplement of durable medical equipment, Emergency Service and its quantity sufficient at the whole Republic primary care physician dispensaries, primary care polyclinics, regional (city) central polyclinics, besides hospitals (which is demonstrated *as an* attentive side is *bound to* be First Aid or primary medical-sanitation care centers).

At the primary medical-sanitation care centers confirming the protocols of the normality of Staff, the qualification standards for doctors and mid-medical staff, signing the appropriate contracts, assessing the current supervisors, recommend candidates for the position of supervisor and others.

*The* next deputy minister is answerable for Digitalization of the system, running the partnership of private sections with the State, practice on the affairs of digitalization and financial plans, and also work with international finance partial, *as* another deputy minister amends on Republican scientific-practical medical centers.

*The* other deputy minister obtains authority on the medical department of the Defence of Mothers and Children's Health and cope with the issues of the addressed healthy lifestyle of people, resolve *other* specific affairs. On November 12, 2020, another essential decree *was* announced by the President which *was* numbered 6110. The document can be assumed the most consequential conformation is that "medical brigades which consisted of therapist, pediatrician, accoucheurs and mid-medical staff relating to medical patronage so that it is available to support primary health care. What's more, "medical brigade" need to form "medical map" according to families and citizens at the areas where their *own* were associated and vitally they are to *be* delivered specific computers planshets and special transpors which equipped with mobile medical diagnostic tools so *as* decreasing more extra bureaucratic formalism and digitalizing the System, simplifying to gain medical care. The *other* conformation concorded to that decree is "village physicians" *who* get extra *bonus* salary, hence to work at long-distanced place. Furthermore, organizing 315 family physician dispensaries, 52 family polyclinics at villages, 33 family polyclinics at cities, and also establishing medical faculties *as a* component of State Universities in Karshi, Navoi, Jizzakh, Gulistan in order to provide with qualified medical staff among 2021-2023 years are comprehended *as a* compounds of that decree. *The decrees* like those all straightened to actualize the primary health care in the country.

As our president is focusing *on* the whole attention to the partial *of* Medicine, primary health care it would be delightful to express about what is *the* first aid, *who* is its personnels, *ow* many steps should be included. *When an* accident happens to give medical favor by *own* or others is the First Aid. Attentively, effectiveness of health care at the situation of health problem deeply depends on the First Aid, like friend indeed is *a* friend in need. First Aid can be just the whole treatment while either prevent from serious health problems. That's *why the* First Aid is always *at the* peak of attention *as an* inspontaneous solution of every accident should have followed the First Aid Construction of hygienic form.

*The* First Aid can be several typed : Urgent Medical Care, Primary Medical-sanitation Aid, Primary Medical-sanitation Aid till Physician,

Primary Medical-sanitation Aid with Physician. Legally, First Aid is *not* considered *as* Medical Process caused by *not to* be medical specialists *who* give help to patients. At other kinds of Aid medical staff served *who* are nurses, pharmacists, tooth technics, accoucheurs and other mideducated medics and their aids are admitted in legal sphere. It is *not* recommended to show First Aid's some special actions by non-specialists. Though First Aid which provided with simple complex of actions without any medicine by non-specialists is *not* acclaimed *as* health care, this term is kept among *a* lot of countries.

Urgent Medical Care, Primary Medical-sanitation Aid, Primary Medical-sanitation Aid till Physician, Primary Medical-sanitation Aid with Physician can be treated at home, in any place where is not hospitals or polyclinics and they are to *be* practiced by specialists therefore they are legally admitted. First Aid contained 3steps *of* complex actions according to types of accidents.

Immediately get patients separated from damaging area *or* discomfortness.

Perform First Aid relating to kind of the accident.

Deliver to *be sent* the nearest hospital or polyclinics the most vital part of primary medical-sanitation care is the protection *ofte* mothers and children which state social-medical actualized system aimed to bring up healthy, physically and mentally perfect generation and keep the healthiness of the mothers and children. In Uzbekistan the defence of the Mothers and children is based on establishing special treating-prophylactic foundation's fields which is capable to get accoucheurs-genecologic and pediatric therapy, and also, defending social-legally the mothers and children, the legality of protecting the labour *of women*, pregnant and breast-feed mothers. *The* Departnnent of the Protection of Mothers and Children is divided into 2 subdivisions: accoucheur-genecology and prophylactic therapy *of* children. *The* care of accoucheur-genecology is functioned *at* special dispensaries of accoucheur-genecology, maternity homes, maternity complexes including *women's* consultation rooms, the special departnnent of hospitals, the special clinics *of* the faculty *of* Medical Institutes, the special cabinets of Medical-sanitation departnnent of industrial objects. *Women's* consultation rooms work with the offices healthening desks of Pregnants, the screening center of the Mothers and Children, perinatal centers, med-genetic consult rooms, "Family and Marriage" consult room, polyclinics of the Mothers and Children, the specialized branches of hospitals.
