Research shows that the causes of crime, the formation of antisocial behavior and personality traits in the individual, as well as the commission of various offenses, factors that undermine the law or the rule of law, prevent the observance of the family environment. occurs. After all, an unhealthy social and psychological environment in the family plays an important role in the origin of any offense. It is well-known that the root of all transgressions and vices is formed in the family. The family plays an important role in the formation of human qualities, such as preparing a person for social life, spiritual and moral upbringing, and behavior in the process of social relations with individuals. Today, 40 percent of crimes against life and health, one in four murders, one in five intentional bodily harm, and one in eight insults and slander are committed in the family.

Law enforcement officers are one of the first links in the protection against harassment and violence, and the skills of the officers and the initial actions taken in the event of violence are of great importance.
